**I. Essential Qualifications for the posts at Sl. No. 1, 2, 3 & 4 (Asst. Prof. of Psychiatry, Neurology, Neurosurgery and Radio-diagnosis).**

- (i) A recognized MBBS degree qualification included in the First or Second Schedule or Part II of the Third Schedule (other than licentiate qualifications) to the Indian Medical Council Act, 1956 (102 of 1956). Holders of educational qualifications included in Part II of the Third Schedule should also fulfill the conditions specified in sub-section (3) of section 13 of the Indian Medical Council Act, 1956 (102 of 1956).
- (ii) Post-graduate degree in the concerned Speciality or Super-speciality mentioned in Section – A of Schedule-VI.
- (iii) At least three years' teaching experience as Senior Resident or Tutor or Demonstrator or Registrar in the concerned Speciality or Super-speciality in a recognized teaching institution after obtaining the first Post-graduate degree qualification.

**Age Limit:** Not exceeding 40 years (Relaxable as per Government orders issued from time to time).

- 1. Master Degree in Psychology or clinical Psychology from a recognized University or Institute.
- 2. Master in Philosophy in Clinical Psychology/Medical & Social Psychology/Diploma in Medical & Social Psychology from a recognized University or Institute.
- 3. Doctorate Degree (Ph.D.) in Clinical Psychology from a recognized University or Institution.
- 4. 5 years teaching and research experience (including at least 2 years as Asst. Prof. of Clinical Psychology).

**Age Limit:** Not exceeding 56 years (Relaxable as per Government orders issued from time to time).

**Note:** The qualification regarding experience is relaxable at the discretion of the selection Committee in the case of candidates otherwise well qualified.



**IV. Essential Qualifications for the posts at Sl. No. 7 (Assistant Professor of Clinical Psychology)**

1. Master Degree in Psychology or Clinical Psychology from a recognized University or Institute.
2. M.Phil. in Clinical Psychology/Medical and Social Psychology or Diploma in Medical & Social Psychology from a recognized University or Institute.
3. 3 years teaching/research experience as Clinical Psychologist / Tutor in Clinical Psychology in a Psychiatric Hospital, Psychiatric Clinic, Child Guidance Clinic or Department of Psychiatry in a General Hospital.

**Desirable:**

1. Ph. D. in Clinical Psychology or Anthropology or Social Psychology or Sociology from a recognized University or Institute.
2. Three years experience in Individual and Group Psychotherapy and Counselling Techniques.

**Age Limit:** Not exceeding 56 years (Relaxable as per Government orders issued from time to time).

**Note:** The qualification regarding experience is relaxable at the discretion of the selection Committee in the case of candidates otherwise well qualified.

4. 5 years teaching and research experience including at least 2 years as Asst. Prof. of Psychiatric Social Work in a recognized Institution.

1. Experience in Psychotherapy and Counselling Techniques.

**Age Limit:** Not exceeding 56 years (Relaxable as per Government orders issued from time to time).

**Note:** The qualification regarding experience is relaxable at the discretion of the selection Committee in the case of candidates otherwise well qualified.

1. Master Degree in Social Work or Sociology or Applied Sociology from a recognized University or Institution.
2. M.Phil. in Psychiatric Social Work from a recognized University or Institution.
3. 3 years teaching and research experience as Psychiatric Social Worker/ Tutor in Psychiatric Social Work in a Mental Hospital, Child Guidance Clinic or Psychiatric Department of a General Hospital.

**Desirable:** Doctorate Degree in Social Work or Sociology or Applied Sociology or from a recognized University or Institution.

**Age Limit:** Not exceeding 56 years (Relaxable as per Government orders issued from time to time)

**Note:** The qualification regarding experience is relaxable at the discretion of the selection Committee in the case of candidates otherwise well qualified.

**VIII. Essential Qualifications for the posts at Sl. No. 11 (Assistant Professor of Neuro Psychology)**

1. Master Degree in Psychology or Clinical Psychology from a recognized University or Institute.
2. M. Phil. in Clinical Psychology/Medical and Social Psychology or Diploma in Medical & Social Psychology (2 years course) from a recognized University or Institution.
3. 3 years teaching/research experience as Neuro- Psychologist / Tutor in Clinical Psychology in a Psychiatric Hospital, Psychiatric Clinic, Child Guidance Clinic or Department of Psychiatry in a General Hospital.

**Desirable:**

1. Doctorate Degree (Ph. D.) in Clinical Psychology or Anthropology or Social Psychology or Sociology.
2. Experience in Individual and Group Psychotherapy and Counselling Techniques.

**Age Limit:** Not exceeding 56 years (Relaxable as per Government orders issued from time to time).
